Electoral (Fees) Determination 2009

Disallowable instrument DI2009— 105

made under the

Electoral Act 1992, s 8 (Determination of Fees)

1. This determination may be cited as *Electoral (Fees) Determination 2009*.
2. This determination takes effect on the day after the determination is notified under the *Legislation Act 2001*.
3. The ACT Electoral Commission REVOKES disallowable instrument No. DI2008-154 (Electoral (Fees) Determination 2008).
4. The ACT Electoral Commission DETERMINES that the fees payable for the purposes of the Act are as set out in the Schedule.
5. The ACT Electoral Commission DETERMINES that fees are payable by persons or organisations receiving the goods or services specified in this determination.
6. The ACT Electoral Commission DETERMINES that fees are payable to the ACT Electoral Commission.
7. The ACT Electoral Commission DETERMINES that fees are payable after a service has been supplied, by the due date specified in the invoice for the service.
