Medicines, Poisons and Therapeutic Goods Act 2008, s 197 (Determination of Fees)

1 Name of instrument

This instrument is the Medicines, Poisons and Therapeutic Goods (Fees) Determination 2009 (No 1).

2 Commencement

This instrument commences on the day after notification.

3 Determination of fees

The fee payable in respect of each matter listed in an item in column 3 of Schedule 1 is the amount listed for that item in column 4.

4 Payment of fees

A fee listed in Schedule 1 is payable to the Territory by the person identified in column 6.

5 Refunding of fees

Column 5 of Schedule 1 specifies what amount, if any, of a fee amount identified in column 4 is non-refundable. A non-refundable amount is included to cover the costs associated with the processing and administration of an application.

6 Licence terms

The amounts listed in columns 4 and 5 are based on a 1 year licence. Although the Act permits licences to be issued for up to three years, a policy decision has been made requiring licences to be renewed annually.
