### 1. Name of instrument

The name of this instrument is the Road Transport (General) (Refund Fee and Dishonoured Cheque Fee) Determination 2009 (No 1).

### 2. Commencement

This instrument commences the day after notification on the ACT Legislation Register.

### 3. Revocation of previous determination

Disallowable instrument DI 2008-109 Road Transport (General) (Refund Fee and Dishonoured Cheque Fee) Determination 2008 (No 1) is revoked.

### 4. Determination of fees

- (1) The fee payable for a matter listed in an item in column 2 of the Schedule which occurs on or before 30 June 2009 is the amount for that item in column 3.
- (2) The fee payable for a matter listed in an item in column 2 of the Schedule which occurs on or after 1 July 2009 is the amount for that item in column 4.

### 5. Payment of fee

A fee listed in the Schedule is payable to the Australian Capital Territory Road Transport Authority by the applicant for the matter to which the application relates.
