Road Transport (General) (Numberplate Fees) Determination 2009 (No 1)

Disallowable Instrument DI2009–72

made under the

Road Transport (General) Act 1999, section 96 (Determination of fees, charges and other amounts)

1. Name of instrument

The name of this instrument is the Road Transport (General) (Numberplate Fees) Determination 2009 (No 1).

2. Commencement

This instrument commences the day after notification on the ACT Legislation Register.

3. Revocation of previous determination

Disallowable instrument DI 2008-297 Road Transport (General) (Numberplate Fees) Determination 2008 (No 2) is revoked.

4. Determination of fees

- (1) The fee payable for a matter listed in an item in column 2 of the Schedule which occurs on or before 30 June 2009 is the amount for that item in column 3.
- (2) The fee payable for a matter listed in an item in column 2 of the Schedule which occurs on or after 1 July 2009 is the amount for that item in column 4.

5. Payment of fee

A fee listed in the Schedule is payable to the Authority by the applicant for the numberplates or other matter to which the application relates.

6. Exclusions

- (1) For items 6 to 19 in column 1 of the Schedule, a fee listed in columns 3 or 4 of the Schedule is not payable for the replacement or remake of a numberplate if the replacement or remake of that plate is required because of a defect in the manufacture of that plate.
- (2) For items 55 to 71 in column 1 of the Schedule, a fee listed in columns 3 or 4 of the Schedule is not payable for the transfer of rights to a non-standard registration number if any of the following circumstances applies:
 - (a) a number plate bearing a non-standard registration number is allocated to a vehicle for the first time following the purchase by a person (the **purchaser**) of the rights to that number as a gift for another person (the **transferee**), and the transfer of rights is from the purchaser to the transferee;

- (b) the rights to the non-standard registration number are transferred to a person (the transferee) who is the executor or a beneficiary of the deceased estate of a person who held those rights at the time of the person's death, and a copy of the death certificate and the deceased person's will, or a letter from the Public Trustee, has been provided to the Authority as evidence that the transferee is entitled to have the rights to the number transferred to that person;
- (c) there is a change in the legal name of the person or body holding the rights to a non-standard registration number but there is no change in the beneficial ownership of the rights; or
- (d) the transfer of rights to a non-standard registration number is required or authorised by order of the Family Court of Australia, and a copy of the order is provided to the Authority.

7. Definitions

In this determination:

Authority means the Australian Capital Territory Road Transport Authority under the Road Transport (General) Act 1999, section 16.
