# Domestic Animals (Fees) Determination 2009 (No 1)

#### Disallowable Instrument DI2009-81

made under the

Domestic Animals Act 2000, Section 144 - Determination of Fees

#### 1. Name of instrument

This instrument is the Domestic Animals (Fees) Determination 2009 (No 1).

#### 2. Commencement

This instrument commences on 1 July 2009.

#### 3. Revocation

Disallowable Instrument number DI 2008 – 156 (Domestic Animals (Fees) Determination 2008 (No 2)) is revoked.

#### 4. Determination of fees

The fee payable in respect of each matter listed in an item in column 3 of schedule 1 is the amount listed for that item in column 5 of that schedule.

### 5. Payment of fee

A fee listed in schedule 1 is payable to the Territory by the person requesting the goods or service listed.

## 6. Waiver and refund of fees

- (1) The Registrar may waive, completely or partly, the fee payable for the sale of a dog from the pound if the Registrar is satisfied that the sale is made to a person as part of a program the main purpose of which is to rescue animals.
- (2) The Registrar may refund a fee paid to the Territory for the issue of a permit to keep a dog or cat that is not desexed if:
  - (a) the permit holder/s relocate interstate;
  - (b) the animal is desexed within three years of the date of issue of the permit; or
  - (c) the animal dies within three years of the date of issue of the permit.
- (3) The amount of the refund to be paid under section 6(2) is calculated by having regard to the event set out in column 1 of schedule 2 and applying the relevant amount set out in column 3 for that event.
