

Nature Conservation (Fees) Determination 2010 (No 2)

Disallowable Instrument DI2010—143

made under the

Nature Conservation Act 1980, section 88 – Determination of fees

1 Name of instrument

This instrument is the Nature Conservation (Fees) Determination 2010 (No 2).

2 Commencement

This instrument commences on 1 July 2010.

3 Revocation of previous determination

The Nature Conservation (Fees) Determination 2010 (No 1) DI2010—8 is revoked.

4 Determination of fees

The fee payable in respect of each matter listed in an item in schedule 1, column 3 is the amount listed for that item in column 5.

5 Payment of fee

A fee listed in schedule 1 is payable to the Territory by the person requesting the goods or service listed.

6 Goods and services tax

Where applicable, GST inclusive fees are marked with a double asterisk (**).

7 Waiver of fees to enter Tidbinbilla Nature Reserve

No daily admission fee is applicable to the Tidbinbilla Nature Reserve on Australia Day (26 January 2011) and for the Tidbinbilla Extravaganza (planned for April 2011).

8 Dictionary

In this instrument:

concession holder means—

- (a) a person who holds one of the following concession cards:
 - (i) a card issued by Centrelink or the Department of Veterans' Affairs commonly known as a "Pensioner Concession Card";
 - (ii) a Department of Veterans' Affairs Gold Card; or
- (b) a student who holds an appropriate student card identifying the person as a student attending:
 - (i) a school located in the Territory; or
 - (ii) a tertiary education institution located in the Territory.

non-exempt animal means an animal that is not specified in a declaration under section 34(1)(b) of the Act.
