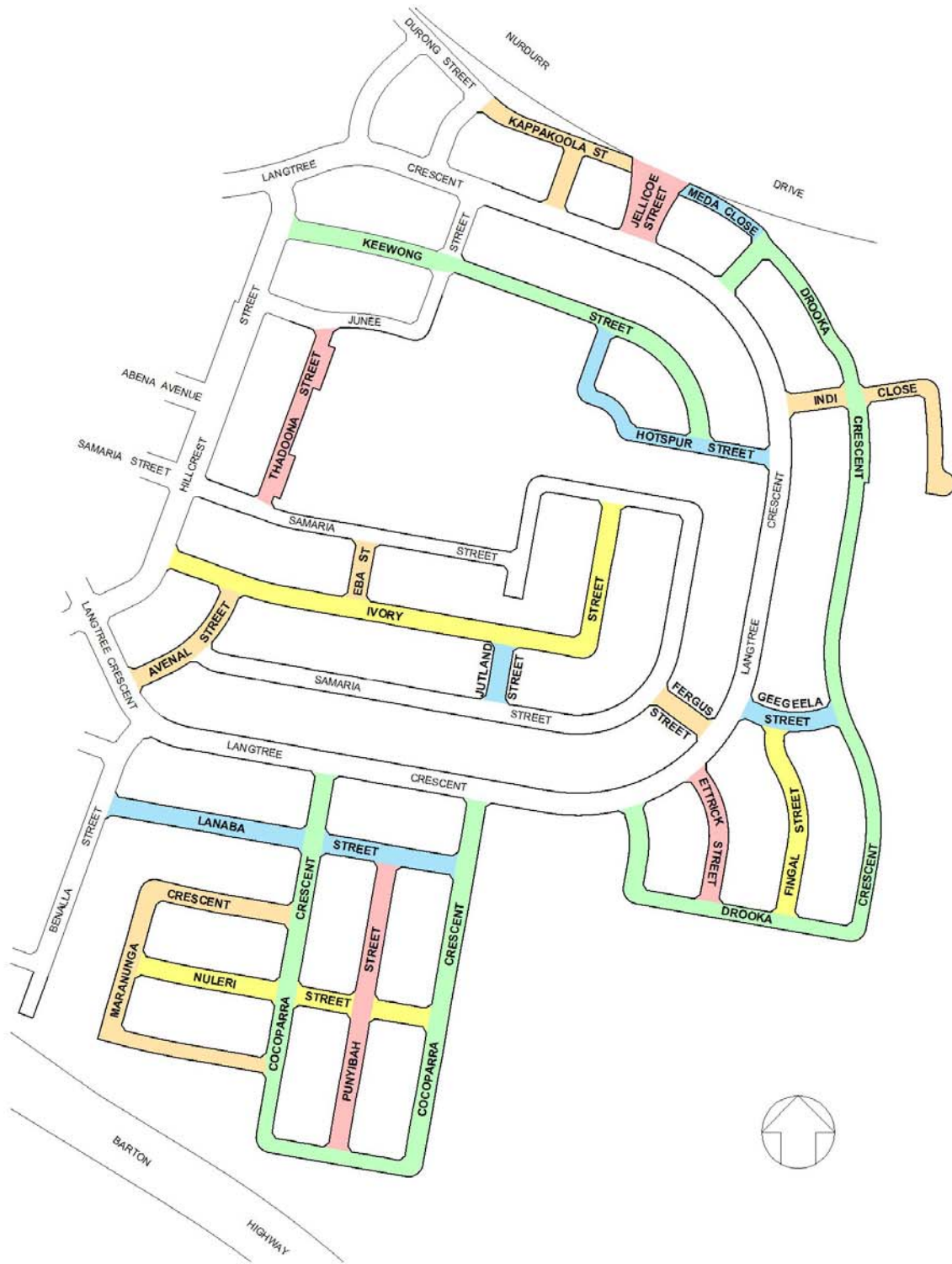

NAME	ORIGIN
Avenal Street	Parish of Avenal, NSW A parish located in the County of Durham, 45 km NE of Singleton, NSW.
Cocoparra Crescent	Parish of Cocoparra, NSW A parish located in the County of Cooper, 25 km NNE of Griffith, NSW. The Cocoparra National Park is located in this parish.
Drooka Crescent	Parish of Drooka, QLD A remote desert parish located in the Bulloo Shire, SE of Birdsville, between Poeppel Corner and Haddon Corner.
Eba Street	Hundred of Eba, SA A hundred in the County of Eyre located in the central River Murray region.
Ettrick Street	Parish of Ettrick, QLD A parish located in the County of Elphinstone near Townsville in northern Queensland.
Fingal Street	Parish of Fingal, VIC A parish in the County of Mornington located near St Andrews Beach, Mornington Peninsula.
Fergus Street	Parish of Fergus, ACT (historical) A historical parish in the County of Cowley, ACT. Bordered on the west by the Mouat Line of the ACT/NSW border and Mt Bimberi and spanning the Cotter River.
Geegeela Street	Hundred of Geegeela, SA A hundred in the County of MacDonnell located in the south-east region of South Australia.

Hotspur Street	Parish of Hotspur, VIC A parish in the County of Normanby. The town of Hotspur is located on the banks of the Crawford River in south western Victoria.
Indi Close	Parish of Indi, VIC A parish in the County of Benambra, Omeo, Victoria. It is located in north-eastern Victoria.
Ivory Street	Parish of Ivory, NSW A parish in the County of Hunter, Land District of Windsor, Hawkesbury Shire, Eastern Division NSW.
Jellicoe Street	Hundred of Jellicoe, SA A hundred in the County of Eyre located in the central River Murray region of South Australia, formerly North Rhine, named in 1910, one of several Germanic placenames.
Jutland Street	Hundred of Jutland, SA A hundred in the County of Sturt located in the central River Murray region of South Australia, formerly South Rhine, named in 1910, one of several Germanic placenames.
Kappakoola Street	Hundred of Kappakoola, SA A hundred in the County of Le Hunte located in the Eyre Peninsula.
Keewong Street	Parish of Keewong, NSW A parish in the County of Mossgiel, Cobar, NSW.
Lanaba Street	District of Lanaba, TAS A district in the municipality of Waratah-Wynyard located in the NW corner of Tasmania.
Maranunga Crescent	Administrative area of Maranunga, NT An administrative area in the Victoria-Daly Shire located south of Darwin in the Daly River region.

Meda Close	District of Meda, WA A district in the Division of Kimberley, Western Australia. Located in north Western Australia east of King Sound.
Nuleri Street	District of Nuleri, WA A district in the Eastern Division, Western Australia. It is located in central WA NNE of Kalgoorlie. Gold mining is undertaken in this area.
Punyibah Street	Parish of Punyibah, ACT (historical) A historical parish in the County of Cowley, ACT. Located beside the Mouat Line of the ACT/NSW border and Tidbinbilla Peak forms the NE corner.
Thadoona Street	District of Thadoona, WA A district in the Division of North-West, Western Australia. It is located 125.2 km NW of Wiluna. Copper mining is undertaken in this area.
