

Domestic Animals (Fees) Determination 2012 (No 1)

Disallowable Instrument DI2012-141

made under the

Domestic Animals Act 2000, Section 144 – Determination of fees

1 Name of instrument

This instrument is the Domestic Animals (Fees) Determination 2012 (No 1).

2 Commencement

This instrument commences on the day after notification.

3 Revocation of previous determination

The *Domestic Animals (Fees) Determination 2011 (No 2)* DI2011—209 is revoked.

4 Determination of fees

The fee payable in respect of each matter listed in an item in schedule 1, column 3 is the amount listed for that item in column 5 of that schedule.

5 Payment of fee

A fee listed in schedule 1 is payable to the Territory by the person requesting the goods or service listed.

6 Waiver and refund of fees

- (1) The registrar may waive, completely or partly, the fees payable in relation to the sale, registration or transfer of registration of a dog from the pound if the registrar is satisfied that the sale is made to a person as part of a program the main purpose of which is to rescue animals.
- (2) The registrar may waive, completely or partly, any fee in cases of hardship. If the Minister issues guidelines under section 24 of the *Domestic Animals Regulation 2001* the registrar must have regard to those guidelines.
- (3) The registrar may refund a fee paid to the Territory for the issue of a permit to keep a dog or cat that is not desexed if:
 - (a) the permit holder/s relocate interstate;
 - (b) the animal is desexed within three years of the date of issue of the permit; or

- (c) the animal dies within three years of the date of issue of the permit.
- (4) The amount of the refund to be paid under section 6(3) is calculated by having regard to the event set out in schedule 2, column 1 and applying the relevant amount set out in column 3 for that event.
