

NAME	ORIGIN	SIGNIFICANCE
Dulfer Street	John Charles Dulfer	Commonwealth public service, engineer
	(1900-1955)	As engineer for roads and bridges with the Federal Capital Commission until 1930, John Dulfer (a civil engineer) was responsible for much construction work during the establishment of Canberra as the seat of government in the late 1920s. He had also worked with the British Phosphate Commission and was stationed at Nauru and Ocean Island as the assistant engineer. On returning to Australia before the Japanese invasion of Nauru, he was involved in a strategically important survey of phosphate deposits throughout the Commonwealth and continued to work for the British Phosphate Commission until his death in 1955.
Hanley Street	Alice Elizabeth (Beth) Hanley QPM	New South Wales police service
	(1916-1999)	Joined NSW Police in 1943, commended for an arrest in 1947 and appointed as a Special Constable. Awarded a Commissioner's Commendation for police studies in 1948, promoted to Special Constable 1st Class in 1952, gained a stipendiary magistrate commendation for performance of duties in 1956, promoted to Special Sergeant 3rd Class in 1958 and awarded a Commissioner's Commendation in 1963 for tracking a violent criminal. In 1972 appointed as Inspector 3rd Class – first woman to achieve this rank, placed in charge of the Women's Police Unit and awarded the Police Long Service and Good Conduct Medal. Awarded a trophy as most outstanding police woman in the State in 1973 and in 1976 awarded the Queen's Police Medal before retirement aged 60 years.

Rattigan Street	Godfrey Alfred Rattigan AO, CBE (1911-2000)	Commonwealth public service, administrator After roles as Deputy Secretary of the Department of Trade and Comptroller-General of Customs, Alf Rattigan was appointed Chairman of the Australian Tariff Board from 1963 to 1973 and Chairman of the Industries Assistance Commission until his retirement in 1976. At the Tariff Board he advocated the reform of Australia's industry protection policies by ensuring tariffs were open and transparent. He sought to make industry economic and efficient. As a visiting fellow at the Australian National University he authored several books on tariffs and industry assistance.
Skermer Street	Victor John William Skermer CBE (1908- 1992)	Commonwealth public service, auditor Served Postmaster General's Department 1925-35, and transferred to the Commonwealth Auditor- General's Office 1935-73 progressing through appointments as Inspector, Senior Inspector, Secretary and Chief Inspector, to Auditor-General for the Commonwealth of Australia 1961-73. Hon Treasurer of the Winston Churchill Memorial Trust 1975-88; Member of the Administrative Appeals Tribunal 1976-81 and Australian representative at international conferences of auditors' general and audit institutions 1961-73.
