

# Medicines, Poisons and Therapeutic Goods (Fees) Determination 2013 (No 1)

Disallowable instrument DI2013-301

made under the

*Medicines, Poisons and Therapeutic Goods Act 2008, s 197 (Determination of Fees)*

**1 Name of instrument**

This instrument is the Medicines, Poisons and Therapeutic Goods (Fees) Determination 2013 (No 1).

**2 Commencement**

This instrument commences on 1 January 2014.

**3 Determination of fees**

The fee payable in respect of each matter listed in an item in column 3 of Schedule 1 is the amount listed for that item in column 4.

**4 Payment of fees**

A fee listed in Schedule 1 is payable to the Territory by the person identified in column 6.

**5 Refunding of fees**

Column 5 of Schedule 1 specifies what amount, if any, of a fee amount identified in column 4 is non-refundable. A non-refundable amount is included to cover the costs associated with the processing and administration of an application.

**6 Licence terms**

The amounts listed in columns 4 and 5 are based on a 1 year licence. Although the Act permits licences to be issued for up to three years, a policy decision has been made requiring licences to be renewed annually.

**7      Revocation**

This instrument revokes DI2012-264 effective on 1 January 2014.
