1 Name of instrument

This instrument is the *Cooperatives (Fees) Determination 2015*.

2 Commencement

This instrument commences on 1 July 2015.

3 Revocation

This instrument revokes DI2014-120, the *Cooperatives (Fees) Determination 2014*.

4 Determination of fees

- (2) The fee for a matter stated in an item in the schedule, column 2 is payable by the person requesting the service.

5 Payment of fees

The fee payable for a matter stated in an item in the schedule, column 2 is payable to the Territory.
