# Legal Profession (Bar Council Fees) Determination 2015 (No 1)

## 1 Name of instrument

This instrument is the *Legal Profession (Bar Council Fees) Determination 2015 (No 1)*.

## 2 Commencement

This instrument commences on the day after it is notified.

## 3 Determination of fees

The fee payable for an application for the grant or renewal of a practicing certificate, for the level of seniority listed in column 1 of the attached schedule, is the amount listed in column 2 of the attached schedule. The fee payable for membership is the amount listed in column 3.

## 4 Payment of fees

A fee listed in the schedule is payable to the ACT Bar Association by the person requesting the barrister practising certificate.

A fee may be paid by instalments if the person requesting the barrister practising certificate makes a written request to do so and the ACT Bar Association agrees in writing.

## 5 Goods and services tax (GST)

Barrister practising certificates are exempt from the payment of GST.

## 6 Revocation

The instrument revokes the Disallowable Instrument DI2014–57.
