## 1. Name of Instrument

This instrument is the Road Transport (Public Passenger Services) Maximum Fares for Taxi Services Determination 2015 (No 1).

## 2. Revocation of Previous Instrument

Disallowable Instrument DI2014-147 (as notified on the ACT Government Legislation Register) is revoked.

## 3. Determination

I determine that the maximum fares relating to the hiring or use of a taxi are as specified in the Schedule.

## 4. Payment of Fare

A fare to which this determination applies is payable by a customer for using taxi services and is payable to the taxi driver.
