

# Road Transport (General) Refund and Dishonoured Payments Fees Determination 2015 (No 1)

## Disallowable Instrument DI2015–97

made under the

***Road Transport (General) Act 1999, section 96 (Determination of fees, charges and other amounts)***

---

### 1 Name of instrument

The name of this instrument is the *Road Transport (General) Refund and Dishonoured Payments Fees Determination 2015 (No 1)*.

### 2 Commencement

This instrument commences the day after its notification.

### 3 Revocation

Disallowable instrument DI2014-91, *Road Transport (General) Refund and Dishonoured Payments Fees Determination 2014 (No 1)*, is revoked.

### 4 Determination of fees

- (1) The fee payable for a thing listed in an item in column 2 of part 1 of schedule 1 where the refund is made on or before 30 June 2015 is the amount for that item in column 3.
- (2) The fee payable for a thing listed in an item in column 2 of part 1 of schedule 1 where the refund is made on or after 1 July 2015 is the amount for that item in column 4.
- (3) The fee payable for a thing listed in an item in column 2 of part 2 of schedule 1 where the dishonour of the payment is processed on or before 30 June 2015 is the amount for that item in column 3.
- (4) The fee payable for a thing listed in an item in column 2 of part 2 of schedule 1 where the dishonour of the payment is processed on or after 1 July 2015 is the amount for that item in column 4.

### 5 Payment of fees

- (1) A fee mentioned in part 1 of schedule 1 is payable to the road transport authority by the applicant for the refund.
- (2) The fee mentioned in subclause (1) may be deducted from the fee being refunded.
- (3) A fee mentioned in part 2 of schedule 1 is payable to the road transport authority by the person who made the payment that is dishonoured.

## 6 Definitions

In this instrument:

*credit card* includes a debit card.

*fee* includes a charge or other amount.
