1 Name of instrument

This instrument is the *Work Health and Safety (Fees) Determination 2017*.

2 Commencement

This instrument commences on 1 July 2017.

3 Revocation

This instrument revokes DI2016-68, the *Work Health and Safety (Fees) Determination 2016*.

4 Determination of fees

- (2) The fee for a matter stated in an item in the schedule, column 2 is payable by the person requesting the service.

5 Payment of fees

The fee payable for a matter stated in an item in the schedule, column 2 is payable to the Territory.

This fee is to undertake the assessment of the relevant experience in order for the applicant to be provided the opportunity to expand the scope of work authorised under their licence issued in their home jurisdiction. 	Application for an asbestos removal licence (Class B) or to renew the licence <i>Explanatory Note: This fee has been removed and replaced with an application and term fee.</i>
