| Category of Premises | Description of veterinary services offered at premises |
|-------------------------|---|
| 1 | Veterinary consulting rooms where a restricted act of veterinary science (other than major veterinary surgery or emergency care) may be carried out. |
| 2 | Veterinary clinics where a restricted act of veterinary science, including major veterinary surgery, may be carried out. |
| 3 | Mobile veterinary clinics are a vehicle, including a trailer that may be moved from one location to another, and is modified to operate as a veterinary clinic. |
| 4 | Veterinary hospitals where a restricted act of veterinary science, including major veterinary surgery and emergency care, may be carried out, and higher level of diagnostic facilities than are available at a veterinary clinic are provided. |
| 5 | Mobile veterinary hospitals are a vehicle, including a trailer that may be moved from one location to another, and is modified to operate as a veterinary hospital. |

^{*}Major veterinary surgery s.71 (2) means a restricted act of veterinary science that-

- (a) includes the carrying out of a procedure that-
 - (i) according to current standards of veterinary practice, should not be undertaken without the administration of an anaesthetic (other than a local anaesthetic); or
 - (ii) involves a spinal anaesthetic; or
- (b) is prescribed by regulation.
