

# Stock (Minimum Stock Levy) Determination 2019

## Disallowable instrument DI2019–130

made under the

**Stock Act 2005, s 7A (Minimum stock levy)**

---

### 1 Name of instrument

This instrument is the *Stock (Minimum Stock Levy) Determination 2019*.

### 2 Commencement

This instrument commences on 1 July 2019.

### 3 Determination of minimum stock levy

The minimum stock levy is—

- (a) for a small landholding—nil; or
- (b) in any other case—\$48.10.

### 4 Payment of minimum stock levy

The minimum stock levy is payable to the Territory by a person who, in a financial year, is the occupier of land held under a lease permitting the carrying of stock.

### 5 Dictionary

In this instrument, *small landholding* means—

- (a) a landholding of less than 10 hectares; or
- (b) a landholding that has a stock-carrying capacity of less than 50 Dry Sheep Equivalent.

*Note* The stock-carrying capacity of a landholding is declared by the Director-General under section 7 of the *Stock Act 2005*.

## **6 Revocation**

This instrument revokes the *Stock (Minimum Stock Levy) Determination 2018 (DI2018–157)*.
