Race and Sports Bookmaking Act 2001, section 97 (Determination of fees)

1 Name of instrument

This instrument is the *Race and Sports Bookmaking (Fees) Determination 2020*.

2 Commencement

This instrument commences on 1 July 2020.

3 Determination

I determine that the fee payable for a matter described in column two of Schedule 1 to this instrument is the amount mentioned in column three.
