1 Name of instrument

The name of this instrument is the *Road Transport (General) (Parking Permit Fees) Determination 2022 (No 2).*

2 Commencement

This instrument commences on 1 September 2022.

3 Determination of fees

- (1) The fee payable for a parking permit specified in column 2 of schedule 1 that commences on or after 1 July 2022 and ends on or before 31 August 2022 is the amount set out in the corresponding entry in column 3.
- (2) The fee payable for a parking permit specified in column 2 of schedule 1 that commences on or after 1 September 2022 is the amount set out in the corresponding entry in column 4.
- (3) The fee payable for a thing listed in an item in column 2 of part 1 of schedule 2 where the refund is made on or after 1 July 2022 and ends on or before 31 August 2022 is the amount set out in the corresponding entry in column 3.
- (4) The fee payable for a thing listed in an item in column 2 of part 1 of schedule 2 where the refund is made on or after 1 September 2022 is the amount set out in the corresponding entry in column 4.
- (5) The fee payable for a thing listed in an item in column 2 of part 2 of schedule 2 where the dishonour of the payment is processed on or after 1 July 2022 and ends on or before 31 August 2022 is the amount set out in the corresponding entry in column 3.
- (6) The fee payable for a thing listed in an item in column 2 of part 2 of schedule 2 where the dishonour of the payment is processed on or after 1 September 2022 is the amount set out in the corresponding entry in column 4.

4 Payment of fees

- (1) The fee for a parking permit listed in column 2 of schedule 1 is payable to the road transport authority by the applicant for the parking permit.
- (2) A fee mentioned in part 1 of schedule 2 is payable to the road transport authority by the applicant for the refund.

(3) A fee mentioned in part 2 of schedule 2 is payable to the road transport authority by the person who made the payment that is dishonoured.

5 Definitions

In this instrument:

fee includes a charge or other amount. *parking permit*—see the *Road Transport (Safety and Traffic Management) Regulation* 2017, dictionary. *credit card* includes a debit card.

6 Revocation

The *Road Transport (General) (Parking Permit Fees) Determination 2022 (No 1)* (DI2022-66) is revoked.
