

# Road Transport (General) Vehicle Registration and Related Fees Determination 2024 (No 1)

## Disallowable Instrument DI2024-84

made under the

**Road Transport (General) Act 1999, section 96 (Determination of fees, charges and other amounts)**

---

### 1 Name of instrument

The name of this instrument is the *Road Transport (General) Vehicle Registration and Related Fees Determination 2024 (No 1)*.

### 2 Commencement

This instrument commences the day after its notification.

### 3 Revocation

Disallowable instrument DI2023-54, *Road Transport (General) Vehicle Registration and Related Fees Determination 2023 (No 2)*, is revoked.

### 4 Determination of fees

- (1) The 12 month registration fee payable for a thing listed in an item in column 2 of part 1 of schedule 1 for registration periods commencing on or before 30 June 2024 is the amount listed for that item in column 3.
- (2) The 12 month registration fee payable for a thing listed in an item in column 2 of part 1 of schedule 1 for registration periods commencing on or after 1 July 2024 is the amount listed for that item in column 4.
- (3) The fee for a registration period for a thing listed in part 1 of schedule 1 which is less than 12 months is determined in accordance with the applicable formula set out in part 2 of schedule 1.
- (4) The 12 month registration fee payable for a thing listed in an item in column 2 of part 3 of schedule 1 for registration periods commencing on or before 30 June 2024 is the amount listed for that item in column 3.
- (5) The 12 month registration fee payable for a thing listed in an item in column 2 of part 3 of schedule 1 for registration periods commencing on or after 1 July 2024 is the amount listed for that item in column 4.
- (6) The fee payable for a thing listed in an item in column 2 of part 4 of schedule 1 which is paid for on or before 30 June 2024 is the amount for that item in column 3.
- (7) The fee payable for a thing listed in an item in column 2 of part 4 of schedule 1 which is paid for on or after 1 July 2024 is the amount for that item in column 4.

- (8) The fee payable on or before 30 June 2024 by external organisations for the provision of data sourced from the Road Transport Authority database is the applicable fee payable in columns 3, 4 and 5 of schedule 2.
- (9) The fee payable on or after 1 July 2024 by external organisations for the provision of data sourced from the Road Transport Authority database is the applicable fee payable in columns 3, 4 and 5 of schedule 3.
- (10) Fees payable at items 1.1 to 1.6, 2.1 to 2.4 and 7.1 and 7.2 are only applicable for registrations commencing on or before 30 June 2024. For registrations commencing on or after 1 July 2024 the registration fees for these vehicles are prescribed by items 1A.1.1 to 1A.6.6, 2A.1.1 to 2A.6.4 and 7A.1 to 7A.4 as the registration of these vehicles transitions to emissions-based registration.

## **5 Payment of fees**

A fee for a thing in schedules 1, 2 and 3 is payable to the road transport authority by the applicant for the thing to which the application relates. An amount equal to the regulatory component of the heavy vehicle registration fees paid (items 16.1 to 20.3, part 3, schedule 1) to the road transport authority will be transferred to the National Heavy Vehicle Regulator Fund.

## **6 Discounted fees items 1.1 to 8.15—payment of vehicle registration**

A 12 month registration fee in columns 3 or 4 for items 1.1 to 8.15 in part 1 of schedule 1 shall be discounted by 2% if paid in full.

## **7 Exemption from item 22.3—payment for vehicle’s registration dishonoured**

A fee in columns 3 or 4 for item 22.3 in part 4 of schedule 1 is not payable in relation to a vehicle if the vehicle’s registration is cancelled because payment for the vehicle’s registration by the former registered operator is dishonoured.

## **8 Exemption from item 26.2—Commonwealth agencies and State and Territory authorities**

- (1) A fee in columns 3 or 4 for item 26.2 in part 4 of schedule 1 is not payable if the search of records is requested by a Commonwealth agency or a State or Territory authority and the provision of the results of the search to the agency or authority is:

- (a) required or authorised by law; or
- (b) reasonably necessary for the enforcement of the criminal law or of a law imposing a pecuniary penalty, or for the protection of the public revenue.

- (2) In this clause:

**Commonwealth agency** means an agency under section 6 of the *Privacy Act 1988* (Cwlth), definition of **agency**.

**State or Territory authority** means a State or Territory authority under section 6C (3) of the *Privacy Act 1988* (Cwlth).

## **9 Exemptions from items 26.3 —defective and lost registration certificates**

- (1) A fee in columns 3 or 4 for item 26.3 in part 4 of schedule 1 is not payable if the replacement of the registration certificate is required because:

- (a) of a defect in the manufacture of the certificate; or
- (b) the certificate was posted to a person but was not received by the person.

## 10 Goods and services tax

Where applicable, fees are inclusive of GST.

## 11 Definitions

In this instrument:

**approved premises**—see the *Road Transport (Vehicle Registration) Regulation 2000*, dictionary.

**articulated bus**—see the *Heavy Vehicle National Law (ACT)*, section 5 (Definitions).

**authorised examiner**—see the *Road Transport (Vehicle Registration) Regulation 2000*, dictionary.

**axle**—see the *Heavy Vehicle National Law (ACT)*, section 5 (Definitions).

**axle group**—see the *Heavy Vehicle National Law (ACT)*, section 5 (Definitions).

**B-double**—see the *Heavy Vehicle National Law (ACT)*, section 5 (Definitions).

**B-double lead trailer** means a semitrailer that is nominated for use as the lead trailer in a B-double combination.

**BEV** means a battery electric vehicle where the only means of propulsion for the vehicle is via an electric motor/s powered by a battery/ies that are recharged by plugging the vehicle into an electric power source external to the vehicle, and does not have an internal combustion engine in the vehicle.

**B-triple**—see the *Heavy Vehicle National Law (ACT)*, section 5 (Definitions).

**B-triple lead trailer** means a semitrailer that is nominated for use as the lead trailer in a B-triple combination.

**B-triple middle trailer** means a semitrailer that is nominated for use as the second trailer in a B-triple combination.

**bus**—see the *Heavy Vehicle National Law (ACT)*, section 5 (Definitions).

**bus (type 1)** means a rigid bus that has 2 axles and an MRC not exceeding 12 tonnes.

**bus (type 2)** means—

(a) a rigid bus that has 2 axles and an MRC exceeding 12 tonnes; or

(b) a rigid bus that has 3 or 4 axles.

**Category AAA vehicle** means a motor vehicle with combined carbon dioxide (CO<sub>2</sub>) emissions of zero grams per kilometre or a BEV or HFCEV or a vehicle modified to be a BEV or HFCEV.

**Category AA vehicle** means a motor vehicle with combined carbon dioxide (CO<sub>2</sub>) emissions of 1g per kilometre or more but no more than 65g per kilometre.

**Category A vehicle** means a motor vehicle with combined carbon dioxide (CO<sub>2</sub>) emissions of 66g per kilometre or more but no more than 130g per kilometre.

**Category B vehicle** means a motor vehicle with combined carbon dioxide (CO<sub>2</sub>) emissions of 131g per kilometre or more but no more than 175g per kilometre.

**Category C vehicle** means a motor vehicle with combined carbon dioxide (CO<sub>2</sub>) emissions of 176g per kilometre or more but no more than 220g per kilometre or an unrated vehicle.

**Category D vehicle** means a motor vehicle with combined carbon dioxide (CO<sub>2</sub>) emissions of 221g per kilometre or more.

*Note: In most circumstances the combined carbon dioxide CO<sub>2</sub> emissions results are available through the Green Vehicle Guide and this is the measure Access Canberra will use where it is applicable. Access Canberra will also utilise other reliable data sources where data is not available through the Green Vehicle Guide. The Australian Design Rules 79 and 81 do not apply to motorcycle type vehicles (ADR L-Group vehicles). As such, CO<sub>2</sub> Emission results are not required to be provided for motorcycle type vehicles and only motorcycles that are BEVs or HFCEVs will be able to be assigned an emission Category.*

**commercial rates** means the applicable cost to a commercial organisation for requested data sourced from the Road Transport Authority database and used for commercial purposes.

**converter dolly**—see the *Heavy Vehicle National Law (ACT)*, section 5 (Definitions).

**cost recovery rates** means the applicable cost to a person who is not part of a commercial organisation for requested data sourced from the Road Transport Authority database.

**dog trailer**—see the *Road Transport (Vehicle Registration) Regulation 2000*, dictionary.

**drawbar**—see the *Road Transport (Vehicle Registration) Regulation 2000*, dictionary.

**fee** includes a charge or other amount.

**GTM**—see the *Road Transport (Vehicle Registration) Regulation 2000*, dictionary.

**GVM**—see the *Heavy Vehicle National Law (ACT)*, section 5 (Definitions).

**lead trailer**, in a combination, means the trailer that is, or that is to be, attached to the prime mover.

**HFCEV** means a vehicle that is propelled by an electric motor/s powered by electricity generated by a hydrogen fuel cell, the vehicle carries hydrogen in tanks refuelled from external sources and does not have an internal combustion engine in the vehicle.

**Historic vehicle** means a vehicle manufactured on or after 1 January 1931 that is at least 30 years old.

**load carrying vehicle** means a vehicle designed and constructed to haul or carry goods and wares in addition to any fuel, water, lubricants, tools and any other equipment or accessories necessary for normal operation of the vehicle.

**long combination truck** means a truck nominated to haul 2 or more trailers.

**medium combination truck** means a truck, other than a short combination truck, nominated to haul one trailer.

**Modified Historic vehicle** means a motor vehicle that is 30 years of age or more that has modifications that would affect its inclusion in the Veteran, Vintage or Historic categories.

**MRC** (mass rating for charging), in relation to a vehicle, means—

- (a) the maximum mass of the vehicle, including any load, recorded on the compliance plate as the GVM, GTM or aggregate trailer mass of the vehicle; or
- (b) in relation to a vehicle for which there is no compliance plate, or where the maximum mass recorded on the compliance plate is no longer applicable—its operating mass.

**multi-combination prime mover** means a prime mover nominated to haul 2 or more trailers.

**nominated** means nominated by the person applying for registration.

**pig trailer**—see the *Heavy Vehicle National Law (ACT)*, section 5 (Definitions).

**pole type trailer**—see the *Heavy Vehicle National Law (ACT)*, section 5 (Definitions).

**prime mover**—see the *Heavy Vehicle National Law (ACT)*, section 5 (Definitions).

**quad-axle group**—see the *Heavy Vehicle National Law (ACT)*, section 5 (Definitions).

**Road Transport Authority database** means the system that includes the registers kept under the road transport legislation.

**semitrailer**—see the *Heavy Vehicle National Law (ACT)*, section 5 (Definitions).

**short combination prime mover** means a prime mover nominated to haul one semitrailer.

**short combination truck** means a truck nominated to haul one trailer where, according to the nomination—

- (a) the combination has 6 axles or fewer; and
- (b) the maximum total mass that is legally allowable for the combination is 42.5 tonnes or less.

**single axle**—see the *Heavy Vehicle National Law (ACT)*, section 5 (Definitions).

**special purpose vehicle** means a vehicle where the primary purpose for which it was built, or permanently modified, was not the carriage of goods or passengers.

**special purpose vehicle (type O)** means a special purpose vehicle (other than a special purpose vehicle (type P))—

- (a) built, or permanently modified, primarily for use on roads; and
- (b) that has at least one axle or axle group loaded in excess of the axle load limits specified in the table of axle load limits.

**Examples—special purpose vehicle (type O)**

mobile cranes, fire engines, truck-mounted concrete pumps and boring plants

*Note 1* These kinds of vehicle may also fall within the definition of **special purpose vehicle (type T)** if they have no axle or axle group loaded in excess of the axle load limits specified in the table of axle load limits.

*Note 2* An example is part of the instrument, is not exhaustive and may extend, but does not limit, the meaning of the provision in which it appears (see Legislation Act, s 126 and s 132).

**special purpose vehicle (type P)** means a special purpose vehicle built, or permanently modified, primarily for—

- (a) off-road use; or
- (b) use on a road related area; or
- (c) use on an area of road that is under construction or repair.

**Examples—special purpose vehicle (type P)**

agricultural tractors, self-propelled agricultural harvesters, bulldozers, backhoes, graders and front-end loaders

*Note* An example is part of the instrument, is not exhaustive and may extend, but does not limit, the meaning of the provision in which it appears (see Legislation Act, s 126 and s 132).

***special purpose vehicle (type T)*** means a special purpose vehicle (other than a special purpose vehicle (type P))—

- (a) built, or permanently modified, primarily for use on roads; and
- (b) that has no axle or axle group loaded in excess of the axle load limits specified in the Table to the definition of ***special purpose vehicle (type O)*** in this subclause.

**Examples—special purpose vehicle (type T)**

mobile cranes, fire engines, truck-mounted concrete pumps and boring plants

*Note 1* These kinds of vehicle may also fall within the definition of ***special purpose vehicle (type O)*** if they have at least one axle or axle group loaded in excess of the axle load limits specified in the Table to that definition.

*Note 2* An example is part of the instrument, is not exhaustive and may extend, but does not limit, the meaning of the provision in which it appears (see Legislation Act, s 126 and s 132).

**tandem axle group** see the *Heavy Vehicle National Law (ACT)*, section 5 (Definitions).

**trailer**—see the *Road Transport (General) Act 1999*.

**tri-axle group**—see the *Heavy Vehicle National Law (ACT)*, section 5 (Definitions).

**truck**—see the *Heavy Vehicle National Law (ACT)*, section 5 (Definitions).

**truck (type 1)** means a truck that has—

- (a) 2 axles and an MRC not exceeding 12 tonnes; or
- (b) 3 axles and an MRC not exceeding 16.5 tonnes; or
- (c) 4 or more axles and an MRC not exceeding 20 tonnes.

**truck (type 2)** means a truck that has—

- (a) 2 axles and an MRC exceeding 12 tonnes; or
- (b) 3 axles and an MRC exceeding 16.5 tonnes; or
- (c) 4 or more axles and an MRC exceeding 20 tonnes.

**twinsteer axle group**—see the *Heavy Vehicle National Law (ACT)*, section 5 (Definitions).

**Unrated vehicle** means a privately or business registered vehicle described on the register as a passenger or goods carrying motor vehicle, with a GVM of 4.5 tonnes or less, that does not have a combined carbon dioxide (CO<sub>2</sub>) emissions rating recorded in the Road Transport Authority database for one or more of the following reasons:

- a) Results of testing for CO<sub>2</sub> emissions to comply with the ADRs and emission labelling requirements have not been provided by the Commonwealth for the vehicle type.
- b) The vehicle has been modified, other than to convert the vehicle to a BEV or HFCEV, under the National Code of Practice for Light Vehicle Construction and Modification to the extent that certification is required, and, if tested, the CO<sub>2</sub> emissions from the vehicle would be expected to have been affected and no testing for CO<sub>2</sub> emissions in line with that required to demonstrate compliance with the ADRs and emission labelling requirements has been undertaken.

**Veteran vehicle** means a vehicle manufactured before 1 January 1919.

**Vintage vehicle** means a vehicle manufactured on or after 1 January 1919 but before 1 January 1931.
