

# Major Events (Cricket Season 2025-26 Events) Notice 2025

## Disallowable instrument DI2025-273

made under the

Major Events Act 2014, section 9 (Important sporting event – notice)

---

### 1 Name of instrument

This instrument is the *Major Events (Cricket Season 2025-26 Events) Notice 2025*.

### 2 Commencement

This instrument commences the day after it is notified.

### 3 Notice of important sporting event—Act, subsections 9 (1) and 10 (1) (a)

The sporting events specified in column 1 of schedule 1, are important sporting events.

### 4 Event organiser—Act, subsection 10 (1) (b)

The organisers of the important sporting events listed in column 1 of schedule 1 are specified in the corresponding row of column 2.

### 5 Proposed time and date—Act, subsection 10 (1) (c)

The proposed times and dates of the important sporting events listed in column 1 of schedule 1 are specified in the corresponding row of column 3.

### 6 Event venue—Act, subsection 10 (1) (d)

The location of the venue for the important sporting events specified in column 1 of schedule 1 are the grounds, including any buildings situated on the grounds, specified in the corresponding row of column 4.

### 7 When notice is in force—Act, subsection 10 (1) (e)

This notice is in effect for the period –

- (a) 28 October 2025 to 29 October 2025;
- (b) 28 November 2025 to 30 November 2025;

- (c) 21 December 2025 to 22 December 2025;
- (d) 27 December 2025 to 28 December 2025;
- (e) 18 February 2026 to 19 February 2026.

**8 Exclusion of prohibited item—Act, subsection 12 (1) (a)**

The following item is excluded from the meaning of *prohibited item* for the important sporting event:

- (a) alcohol.

**9 Expiry**

This instrument expires on 20 February 2026.
