#### 1 Name of instrument

This instrument is the *Tobacco and Other Smoking Products (Fees) Determination 2025 (No 1).* 

#### 2 Commencement

This instrument commences on 1 July 2025.

#### 3 Determination of fees

The fees specified in Schedule 1, Column 3, are the fees payable to the Territory, by the person specified in column 4, for the purposes specified in Column 2.

The fees payable for a licence application under section 47 of the *Tobacco and Other Smoking Products Act 1927* are calculated on a pro rata basis and vary depending on the month in which a licence application is made.

#### 4 Revocation

This instrument revokes the *Tobacco and Other Smoking Products (Fees) Determination 2024 (No 1)* - DI2024-304.
