Domestic Animals Act 2000, Section 144 (Determination of fees)

1 Name of instrument

This instrument is the *Domestic Animals (Fees) Determination 2025 (No 1)*.

2 Commencement

This instrument commences on 1 July 2025.

3 Determination of fees

The fee payable in respect of each item in column 3 of schedule 1 is the amount listed in column 5.

4 Payment of fee

A fee listed in schedule 1 is payable to the Territory by the person requesting the good or service.

5 Waiver, refund or extension of time to pay fees

- (1) The Domestic Animals Registrar or Domestic Animals Deputy Registrar may waive fees in accordance with sections 24(3), 32(4), 70(5) and 92(5) of the *Domestic Animals Act 2000*.
- (2) The Domestic Animals Registrar or Domestic Animals Deputy Registrar may waive, completely or partly, the fees payable in relation to the sale, registration or transfer of registration of a dog or cat from the pound if the registrar is satisfied that the sale is made to a person as part of a program the main purpose of which is to rescue animals.
- (3) The Domestic Animals Registrar or Domestic Animals Deputy Registrar may waive, completely or partly, any fee:
 - (a) in cases of financial hardship; or
 - (b) as part of partnerships with organisations which promote high animal welfare standards, best practice animal management or responsible dog ownership.

- (4) The Domestic Animals Registrar or Domestic Animals Deputy Registrar may refund a fee paid to the Territory for the issue of a permit to keep a dog or cat that is not desexed if:
 - (a) the permit holder/s relocate interstate;
 - (b) the animal is desexed within three years of the date of issue of the permit; or
 - (c) the animal dies within three years of the date of issue of the permit.
- (5) The amount of the refund to be paid under section 5(3) is calculated by having regard to the matter set out in column 1 of schedule 2 and applying the amount in column 3 of schedule 2.
- (6) The Domestic Animals Registrar or Domestic Animals Deputy Registrar may grant an extension of time for the payment of any fee in cases of financial hardship.

6 Goods and services tax

GST is not applicable unless marked with a double asterisk (**).

7 Revocation

This instrument revokes the *Domestic Animals (Fees) Determination 2024 (No 1)* [DI2024-130].
