

Road Transport (General) (Driver Licence and Related Fees) Determination 2026 (No 1)

Disallowable instrument DI2026-44

made under the

Road Transport (General) Act 1999, section 96 (Determination of fees, charges and other amounts)

1 Name of instrument

The name of this instrument is the *Road Transport (General) (Driver Licence and Related Fees) Determination 2026 (No 1)*.

2 Commencement

This instrument commences the day after its notification day.

3 Determination of fees

- (1) I determine that the fee payable for a thing listed in an item in column 2 of part 1 of schedule 1 for a driver licence period commencing on or before 30 June 2026, is the amount listed for that item in column 3.
- (2) I determine that the fee payable for a thing listed in an item in column 2 of part 1 of schedule 1 for a driver licence period commencing on or after 1 July 2026, is the amount listed for that item in column 4.
- (3) I determine that the fee payable for a thing listed in an item in column 2 of part 2 of schedule 1 which is paid for on or before 30 June 2026, is the amount for that item in column 3.
- (4) I determine that the fee payable for a thing listed in an item in column 2 of part 2 of schedule 1 which is paid for on or after 1 July 2026, is the amount for that item in column 4.
- (5) I determine that the fee for a full or provisional licence for a period, other than those listed in part 1 of schedule 1, is the amount worked out in accordance with the applicable formula in part 3 of schedule 1.

4 Payment of fees

A fee for a thing in schedule 1 is payable to the road transport authority by the applicant for the thing to which the application relates.

5 Exemption from fees for item 13—surcharge for changing practical driving test

A fee in columns 3 or 4 for item 13 in part 2 of schedule 1 is not payable if the change of the practical driving test booking is required for reasons beyond the control of the applicant for the changed booking.

6 Exemptions from fees for item 14—issue of replacement driver licence

- (1) A fee in columns 3 or 4 for item 14 in part 2 of schedule 1 is not payable by the holder of a driver licence endorsed with ‘Valid without photo’ if the licence holder is returning to the ACT and the replacement licence is a photographic licence.
- (2) A fee in columns 3 or 4 for item 14 in part 2 of schedule 1 is not payable if the replacement of the driver licence is required because:
 - (a) of a defect in the manufacture of the driver licence; or
 - (b) the driver licence was posted to a person but was not received by the person.

7 Exemption from fees for item 16—Commonwealth agencies and State and Territory authorities

- (1) A fee in columns 3 or 4 for item 16 in part 2 of schedule 1 is not payable if the search of records is requested by a Commonwealth agency or a State or Territory authority and the provision of the results of the search to the agency or authority is:
 - (a) required or authorised by law; or
 - (b) reasonably necessary for the enforcement of the criminal law or of a law imposing a pecuniary penalty, or for the protection of the public revenue.
- (2) In this clause:

Commonwealth agency means an agency under section 6 of the *Privacy Act 1988* (Cwlth), definition of ***agency***.

State or Territory authority means a State or Territory authority under section 6C (3) of the *Privacy Act 1988* (Cwlth).

8 Goods and services tax

Fees may be inclusive of GST, in accordance with the requirements of the *A New Tax System (Goods and Services Tax) Act 1999*.

9 Revocation

This instrument revokes the *Road Transport (General) Driver Licence and Related Fees Determination 2025 (No 3)* (DI2025-224).

Part 3 — Formulas for non-standard full and provisional licence periods

- (1) The fee payable for a full licence issued or renewed for a period not more than 6 years is the amount worked out in accordance with the following formula:

$$(F/60) \times N$$

where:

F is the 5-year fee for a full licence; and

N is the number of months, and part months, rounded up to the nearest number of whole months for which the licence is to be issued or renewed.

Example

Carol's full licence is issued for a period of 5 years, 2 months and 3 weeks. For the formula, **N** is 63. This is because there are 60 months in a 5-year period and the 2 months and 3 weeks are rounded up to 3 months, making a total of 63.

Note An example is part of the instrument, is not exhaustive and may extend, but does not limit, the meaning of the provision in which it appears (see Legislation Act, s 126 and s 132).

- (2) The fee payable for a full licence issued or renewed for a period that is more than 6 years is the amount worked out in accordance with the following formula:

$$X + \{(Y - X) / 48\} \times M$$

where:

X is the fee for the issue of a full licence for 6 years;

Y is the 10-year fee for a full licence; and

M is the number of months, and part months, rounded up to the nearest number of whole months, between 6 years and the date for which the licence is to be issued or renewed.

Example 1

Greg's full licence is issued for a period of 7 years, 4 months and 2 weeks. For the formula, **M** is 17. This is because there are 12 months in a one year period and the 4 months and 2 week period is rounded up to 5 months, making a total of 17.

Example 2

Michelle's licence is issued for a period of 10 years, 7 months and 1 week. For the formula, **M** is 56. This is because there are 48 months in a 4 year period and the 7 months and 1 week are rounded up to 8 months, making a total of 56.

Note An example is part of the instrument, is not exhaustive and may extend, but does not limit, the meaning of the provision in which it appears (see Legislation Act, s 126 and s 132).

- (3) The fee payable for a provisional licence issued or renewed for a period other than 3 years is the amount worked out in accordance with the following formula:

$$(F/36) \times N$$

where:

F is the 3-year fee for a provisional licence; and

N is the number of months, and part months, rounded up to the nearest number of whole months for which the licence is to be issued or renewed.

- Licence fees are rounded down to the nearest 10 cents after doing the above calculations.
