1 Name of instrument

This instrument is the *Race and Sports Bookmaking (Fees) Determination 2026*.

2 Commencement

This instrument commences on 1 July 2026.

3 Determination

I determine that the fee payable for a matter described in column 3 of schedule 1 is the amount mentioned in column 4.

4 Payment of fee

A fee to which this determination applies is payable to the ACT Gambling and Racing Commission by an applicant, an incoming person, an incoming individual and an incoming corporation for the matters to which the application or assessment relates.
