DETERMINATION OF FEES

Determination No. 120 of 1996

EXPLANATORY STATEMENT

This instrument revokes all existing fees determinations under the *Roads and Public Places Act 1937*, namely:-

Determination No 89 of 29 June 1995 published in the ACT Gazette No. S164 of 30 June 1995.

This determination sets fees for the purpose of the *Roads and Public Places Act 1937* and has the effect of increasing the fee from 1 July 1996 for.

- (a) the opening up or the breaking of the surface of a carriageway which has a surface of the type set out in Column 1 of Schedule 1 in relation to that type of surface, and
- (b) the fee for the opening up or the breaking of the surface of a public place, other than a carriageway, which has a surface of the type set out in Column 1 of Schedule 2 shall be the amount set out in a or ascertain in accordance with the formula in Column 2 of Schedule 2 in relation to that type of surface.

The fees are set out below, with previous fees shown in brackets.
