DETERMINATION OF FEES

NO. 236 OF 1996

EXPLANATORY STATEMENT

The Business Names Act 1963 governs the registration of business names in the Australian Capital Territory. In particular section 4A of the Act enables the Minister to determine fees for the purposes of the Act.

This Determination revokes Determination of Fees No. 60 of 1995 made on 21 June 1995 and notified in the Australian Capital Territory Gazette No. S145 of 27 June 1995 and determines that the fees payable for the purposes of the Act shall be as set out in the Schedule to the Determination.

A statement of the old and new fees is attached. Item 9 has been changed to \$10 in line with fees for similar services in other areas of the Registrar-General's Office.

Fees been generally increased by a margin of 3% in accordance with the anticipated movement in 1996/97 of the Consumer Price Index and with a view to full cost recovery, except items 1 and 4 which have been increased having regard to charges levied for similar services in NSW.
