DETERMINATION OF FEES

INSTRUMENT No 288 of 1996

EXPLANATORY STATEMENT

This instrument revokes all existing fee determinations under the Motor Traffic Act 1936, namely;

Determination No 119 of 19 June 1996, notified in the ACT Gazette No S144 of 27 June 1996.

This Determination does not affect the fees charged in the National Heavy Vehicle Registration scheme which the ACT Government is required to enforce under the Road Transport Charges (Australian Capital Territory) Act 1993 (Cwth).

The Determination sets fees for the purpose of the *Motor Traffic Act 1936* and has the effect of creating a new fee structure (private and business) for transactions relating to goods carrying vehicles. Some minor anomalies affecting certain weight categories and some calculations of fees for passenger carrying vehicles and goods carrying vehicles have also been corrected.

Set out below for easy reference are the new fees (and previous fees) which apply to transactions relating to vehicle registration.
