

**AUSTRALIAN CAPITAL TERRITORY  
SCAFFOLDING AND LIFTS ACT 1957  
DETERMINATION OF FEES 1993**

No. 97 of 1993

**EXPLANATORY STATEMENT**

This instrument revokes all existing determinations under section 6B of the Scaffolding and Lifts Act 1957, namely

Determination notice dated 6 July 1992 published in Australian Capital Territory Gazette No. S115

This determination sets fees for the purposes of the Scaffolding and Lifts Act 1957 and also has the effect of exempting persons successfully completing a CIT training course, from the gazetted fees for the examination, issue of learners permits and certificates of competency, where the Chief Inspector signs the certificate. There are fee increases of approximately 3% to that determined in Gazette No. S115. The ratio level for payment of notice of intention to build has been lifted to minimise economic impact of minor alterations. The fees are set out below with previous fees shown in brackets.


