## **EXPLANATORY STATEMENT**

These instruments revoke all existing fees determinations under the Motor Traffic Act 1936, namely:-

The determinations set fees for the purpose of the Motor Traffic Act 1936 and have the effect of increasing fees for registration of vehicles, driver licences, permits, number plates and parking labels. The fees are set out below, with previous fees shown in brackets.
