EXPLANATORY STATEMENT

This instrument revokes the following fee determinations under the Motor Traffic Act 1936, so far as they relate to the car parks listed below.

Determination No 173 of 2 December 1992 published in the Australian Capital Territory Gazette, No S224 of 7 December 1992,

Determination No 113 of 24 June 1992 published in the Australian Capital Territory Gazette, No S104 of 30 June 1992, and

Determination No 36 of 24 June 1991 published in the Australian Capital Territory Gazette, No S56 of 1 July 1991

This instrument sets charges for the purposes of Section 163C(2) of the Motor Traffic Act 1936 relating to the car parks listed below. The charges reflect the 1993/94 budget strategy of the Government and are set out below; previous charges are shown in brackets.
