**DETERMINATION OF FEES**

Determination No. 92 of 1993

**EXPLANATORY STATEMENT**

This instrument revokes all existing fees determinations under the Roads and Public Places Act 1937, namely:-

Determination No. 100 of 1 July 1992 published in the ACT Gazette No. S105 of 1 July 1992.

This determination sets fees for the purpose of the Roads and Public Places Act 1937 and has the effect of increasing the fee from 1 July 1993 for:

- (a) the opening up or the breaking of the surface of a carriageway which has a surface of the type set out in Column 1 of Schedule 1 shall be the amount set out in or ascertained in accordance with the formula in Column 2 of Schedule 1 in relation to that type of surface; and
- (b) the fee for the opening up or the breaking of the surface of a public place, other than a carriageway, which has a surface of the type set out in Column 1 of Schedule 2 shall be the amount set out in a or ascertain in accordance with the formula in Column 2 of Schedule 2 in relation to that type of surface.

The fees reflect the 1993/94 budget strategy of the Government and are set out below, with previous fees shown in brackets.
