The fees and charges for lodging for registration and searching of, documents pertaining to land registered pursuant to the above legislation have generally been increased by 3% in accordance with the anticipated movement in 1993/94 of the Consumer Price Index. The new fee structure is as set out in the attached schedule.

Minor fees under twenty dollars (\$20) are to be reviewed on a two yearly obstances. Fees have been compared with those charged by other States and the Norther Territory to ensure equity of treatment. Revenue collected from the fees and charges will place the Registrar's Office at full cost-recovery.
