**DETERMINATION OF FEES**

**NO. 122 OF 1992**

**EXPLANATORY STATEMENT**

This instrument revokes all existing fees determinations under the Motor Traffic Act 1936, namely:-

Determination No. 71 of 21 June 1991 published in ACT Gazette No. S74 on 1 August 1991.

Determination No. 114 of 20 December 1991 published in ACT Gazette No. S5 on 13 January 1992.

This determination sets fees for the purposes of the Motor Traffic Act 1936 and has the effect of increasing fees for registration of vehicles effective on and from 1 August 1992. The fees are set out below, with previous fees shown in brackets.
