# DETERMINATION NO. $&\cap{2}$ of 1992

### EXPLANATORY STATEMENT

UNDER section 40A of the Dog Control Act 1975 the Minister may determine fees for the purposes of this Act.

This determination sets fees for registration or renewal of the registration of a dog and the fee for the return of an impounded dog under the Act. The fees are set out below, the amounts in brackets are the previous fees.

The fee for the registration of a dog, by a keeper not the benefit of a discounted fee, is:

- (a) in the case of a dog that is sterile and older than 12 months; or 24.00 (6.00)
- (b) in the case of a dog that is sterile and aged less than 12 months; or 12.00 (6.00)
- (c) in the case of a dog
  that has not been
  sterilised and older
  than 12 months; 60.00 (25.00)
- (d) in the case of a dog that has not been sterilised and aged less than 12 months; 30.00 (25.00)

The fee for the renewal of the registration of a dog, by a keeper not the benefit of a discounted fee, is:

- (a) in the case of a dog that is sterile; or 12.00 (6.00)
- (b) in the case of a dog that has not been sterilised; 30.00 (25.00)
