EXPLANATORY STATEMENT

This instrument revokes the previous fees determinations under the Motor Traffic Act, namely:-

Determination notice dated 27 July 1990 and published in the Australian Capital Territory Gazette No S56 of 1 August 1990.

This determination sets fees for the purposes of the Motor Traffic Act and has the purpose of varying certain Motor Vehicle Registry fees. The fees are set out below with existing charges in the left column and new fees on the right. The new fees will apply from 1 July 1991.
