## **EXPLANATORY STATEMENT**

## **Background**

The *Gaming Machine Act 2004* regulates the operation of gaming machines in the Territory.

The *Gaming Machine Act 2004* commences on 1 November 2004 and replaces the *Gaming Machine Act 1987*.

All fees previously determined under the *Gaming Machine Act 1987* are repealed by section 179(2) of the *Gaming Machine Act 2004*.

Some matters for which fees are payable under the *Gaming Machine Act 1987* are also applicable under the *Gaming Machine Act 2004*. In these cases, the same level of fee has been determined. These fees are indicated in the attached comparison table with the section of the previous Act (column 1) and fee level (column 2) indicated.

There are also new fees that have been determined under the new legislation. These fees are indicated in the attached comparison table (columns 4 and 5 refer). The reference to the previous fee amount (column 2) for the new fees is shown as "N/A" indicating that there is no previous fee for comparison.

The new fees have been calculated on the basis of the administrative cost to the ACT Gambling and Racing Commission to undertake the activity that the fee relates to.
