TERTIARY ACCREDITATION AND REGISTRATION (FEES)

DISALLOWABLE INSTRUMENT: DI 2005-135

EXPLANATORY STATEMENT

The Tertiary Accreditation and Registration Act 2003 commenced operation on 01 November 2003. The purpose of the Act is to establish an accreditation and training registration framework for vocational education and training and higher education in the ACT, in particular by applying nationally agreed protocols and standards.

Section 111 of the Act provides for fees to be determined for the purposes of the Act.

NEW FEES AND CHARGES

A Diploma/Advanced Diploma/Vocational Graduate Diploma/Vocational Graduate Certificate fee of \$4,523.00 is proposed for 2005-2006. The fee has been based on the same pricing formula as the fee for "Degree/Diploma/Advanced Diploma/Masters/Doctorate and Associate Degree".

Vocational Graduate Diploma and Vocational Graduate Certificates have been introduced by the Australian Quality Framework. This has effected the separation of Higher Education courses from Vocational Education and Training courses, resulting in the former Accreditation category being split into two sub categories;

- (i) Higher Education Accreditation; and
- (ii) Vocational Accreditation.
