Explanatory Statement

Overview

These regulations list ActewAGL as a prescribed entity under section 67 of the *Electoral Act 1992*.

The regulations will allow the ACT Electoral Commission to access ActewAGL customer data for use in connection with the maintenance of the electoral roll.

Detail

Regulations 1, 2 and 3 are formal requirements.

Regulation 1 refers to the name of the Regulations.

Regulation 2 provides for commencement of these regulations on the day after the day on which they are notified in the *Legislation Register*.

Regulation 3 notes these regulations amend the *Electoral Regulations 1993*.

Regulation 4 inserts new regulation 5 which names the ActewAGL retail partnership as a prescribed entity under section 67 of the *Electoral Act 1992*.
