# Gaming Machine (Fees) Determination 2006 (No 1)

**Disallowable Instrument DI2006–112**

made under the

**Gaming Machine Act 2004, section 177 (Determination of Fees)**

## EXPLANATORY STATEMENT

---

The *Gaming Machine Act 2004* (the Act) regulates the operation of gaming machines in the Territory.

This instrument revokes the determination of fees made by Disallowable Instrument DI2004-181, notified on the Legislation Register on 2 September 2004.

Section 177 of the Act provides that the Minister may determine fees for the Act. This instrument provides for fees in relation to applications for licences made to the ACT Gambling and Racing Commission (the Commission) and to certificates issued by the Commission.

This instrument increases fees in accordance with the Wage Price Index estimates for 2006-07. In all cases, fees have been increased by 3.7% and rounded up to the nearest \$5 except for the low level fees (e.g. s22, s99, s107, s112) where rounding up has not occurred as this would create an excessive increase. A comparative table indicating the previous and revised fees is included as an Attachment to this Explanatory Statement.

The list of revised fees contained in this instrument is identical to the list of fees in the Disallowable Instrument DI2004-181 except that this instrument introduces a fee for the issue of a replacement copy of an Approved Supplier's Certificate, pursuant to section 73 of the Act, which was inadvertently omitted from the previous instrument.

All fees are exempt from GST under Division 81 of the *A New Tax System (Goods and Services Tax) Act 1999* (Cwlth).

A determination under section 177 is a disallowable instrument and must be tabled in the Legislative Assembly.
