

# Public Pools (Active Leisure Centre Fees) Determination 2016 (No 1)

Disallowable Instrument DI2016-183

made under the

***Public Pools Act 2015, section 54 (Determination of fees)***

## EXPLANATORY STATEMENT

---

The regulatory framework for the management and operation of Territory owned public pools is provided under the *Public Pools Act 2015* (the Act).

The Territory owns Active Leisure Centre which is administered by the ACT Education Directorate. Active Leisure Centre contains a pool facility under section 10 of the Act. For the purposes of the Act, Active Leisure Centre is a category 1 facility under section 7 as it is owned by the Territory and open to or used by the public (whether or not on payment of money).

Section 54 of the Act provides that the Minister may determine fees for the Act. This instrument provides for fees in relation to use of Active Leisure Centre pool facilities. A determination under section 54 of the Act is a disallowable instrument and must be tabled in the Legislative Assembly in accordance with the *Legislation Act 2001*.

This instrument determines that the fees for Active Leisure Centre are as indicated in column 4 of the Schedule and commence on 1 July 2016.

The fees have not been increased above the Wage Price Index for the Australian Capital Territory, period ending 30 April 2016 (recorded at 2%). Table 1 (below) provides a comparative analysis between the current fees and new fees to apply from 1 July 2016.

The *Public Pools (Active Leisure Centre Fees) Determination 2015 - DI2015-179*, dated 21 June 2015 and notified on the Legislation Register on 23 June 2015 is revoked by this instrument.
