EXPLANATORY STATEMENT

The Gaming Machine Act 2004 (the Act) regulates the operation of gaming machines in the Territory.

This instrument revokes the determination of fees made by Disallowable Instrument DI2016-152, dated 20 June 2016 and notified on the Legislation Register on 30 June 2016.

Section 177 of the Act provides that the Minister may determine fees for the Act. This instrument provides for fees in relation to administrative tasks performed under the Act, including applications and notifications for approvals, licences, authorisation certificates, storage and quarantine permits, permits for linked jackpot arrangements and amendments to those licences, certificates, schedules and permits issued by the ACT Gambling and Racing Commission.

This instrument increases the fees by indexation of 2%, rounded down to the nearest dollar. A comparative table indicating the previous and revised fees is included as an attachment to this Explanatory Statement.

A determination under section 177 is a disallowable instrument and must be tabled in the Legislative Assembly.
