Gaming Machine (Fees) Determination 2018

Disallowable Instrument DI2018 – 193

made under the

Gaming Machine Act 2004, section 177 (Determination of fees)

EXPLANATORY STATEMENT

The *Gaming Machine Act 2004* (the Act) regulates the operation of gaming machines in the Territory.

This instrument revokes the determination of fees made by Disallowable Instrument DI2017-89, notified on the Legislation Register on 5 June 2017.

Section 177 of the Act provides that the Minister may determine fees for the Act. This instrument provides for fees in relation to administrative tasks performed under the Act, including applications and notifications for approvals, licences, authorisation certificates, storage and quarantine permits, permits for linked jackpot arrangements and amendments to those licences, certificates, schedules and permits issued by the ACT Gambling and Racing Commission.

Fees in the 2018-19 financial year have been increased from fees in the previous financial year by indexation of 4%. Calculations are rounded down to the nearest dollar, with the exception of fees that have remained static for over three years, in which case calculations are rounded up to the nearest dollar. The table in this explanatory statement sets out the current fee (in column 3) and the new fee to take effect from 1 July (in column 4) to enable a comparison.

The list of items for which fees are set is identical to the items contained in the Disallowable Instrument DI2017-89.

A determination under section 177 is a disallowable instrument and must be tabled in the Legislative Assembly.
