#### **DETERMINATION OF FEES**

# **INSTRUMENT NO. 234 OF 1999**

#### **EXPLANATORY STATEMENT**

This determination revokes Determination No 223 of 1999, dated 11 June 1999, and notified in the Gazette No. 37 of 15 September 1999.

The Determination sets fees for the purpose of the *Motor Traffic Act 1936* and has the effect of changing fees for drivers' licences. Set out below are the new fees (and previous fees provided in Determination No 223) which apply to transactions relating to drivers' licences.

The Determination makes three changes to Determination 223. The fee for a special licence to comply with a court order is increased from \$34.00 to \$129.00, and the fees for a learner licence and a learner licence receipt are increased from \$14 to \$28. The fees for these items in Determination 223 were listed in error. The fee for a special licence is to be the same as that for a probationary licence as each of these licences may be issued after a driver has been disqualified from holding a full or provisional licence. The fee for a learner licence or learner licence receipt is to remain at the 1998-99 level rather than harmonise with the equivalent fee in NSW as the ACT learner licence scheme, which includes the new "Road Ready" scheme, is unique to the ACT.

In addition, there is no longer an 80 minute driving test so the fee for this item has been deleted.

The instrument will take effect from 1 October 1999.
