DETERMINATION OF FEES

INSTRUMENT NO. 223 OF 1999

EXPLANATORY STATEMENT

This determination revokes Determination No 132 of 1998 of 24 June 1998 and notified in the Gazette No. S167 of 29 June 1998.

The Determination sets fees for the purpose of the *Motor Traffic Act 1936* and has the effect of changing fees for drivers' licences. Set out below are the new fees (and previous fees) which apply to transactions relating to drivers' licences.

The majority of fees have been aligned with the equivalent fee charged in NSW.

The fee for a provisional licence has not been aligned with the equivalent fee for NSW. In NSW provisional licences are issued for one year and cost \$34. In the ACT they are issued for three years and the fee is calculated on a pro rata basis, using the fee for a full licence, which is issued for five years.

Administrative fees associated with driver's licences have been increased in line with the Consumer Price Index, with the fees being rounded to the nearest whole dollar amount.

The fees reflect the 1999-2000 budget strategy of the Government and will take effect from 1 October 1999.
