EXPLANATORY STATEMENT

As a result of the repeal of the *Motor Traffic Act 1936* and related legislation, all fees and charges are re-determined under the new Road Transport legislation.

This instrument has the effect of determining fees, payable in advance, for transactions relating to public vehicle licensing under the *Road Transport (General) Act 1999*. The fees listed below are the same as previously determined under the *Motor Traffic Act 1936*.

This instrument commences on 1 March 2000.
