**DETERMINATION OF FEES**  
**INSTRUMENT NO. 146 OF 1999**

**EXPLANATORY STATEMENT**

The *Consumer Credit (Administration) Act 1996* (the Act) relates to the registration of Credit Providers and Finance Brokers. Section 140 enables the Minister to determine fees for the purposes of the Act.

This Determination revokes Determination of Fees No. 270 notified in the Australian Capital Territory Gazette No. S402 of 10 December 1997 and determines that the various fees payable under the Act shall be as set out in the Schedule to the Determination.

There has been no increase in fees since the last determination of fees was gazetted in December 1997. It is proposed to increase fees by 4.3%. This increase is a cumulative affect of the 1.8% rise in the Consumer Price Index experienced in 1998/99 and the anticipated 2.5% rise in the Consumer Price Index for 1999/2000.
