INSTRUMENT No. 141 OF 1999

This Determination made under section 6B of the Scaffolding and Lifts Act 1957 (the Act) revokes the existing Determination of Fees and sets the fees for the purposes of the Act.

All fees have increased as a result of CPI adjustments in accordance with Government policy.
