DETERMINATION OF FEES

INSTRUMENT NO. 132 OF 1999

EXPLANATORY STATEMENT

This determination revokes Determination No. 153 of 1998 dated 24 June 1998 notified in the ACT Gazette No. S174 of 1 July 1998.

This determination sets fees for the purpose of the *Roads and Public Places Act 1937* and has the effect of increasing the fee from 1 July 1999 for:

- (a) the opening up or the breaking of the surface of a carriageway which has a surface of the type set out in Column 1 of Schedule 1 in relation to that type of surface; and
- (b) the fee for the opening up or the breaking of the surface of a public place, other than a carriageway, which has a surface of the type set out in Column 1 of Schedule 2 shall be the amount set out in a or ascertain in accordance with the formula in Column 2 of Schedule 2 in relation to that type of surface.

The fees have been increased by CPI and reflect the 1999-2000 budget strategy of the Government. The new fees will take effect from 1 July 1999.

For ease of reference the new fees are set out below with previous fees shown in brackets.
