## DETERMINATION OF FEES

## INSTRUMENT NO. 123 OF 1999

## EXPLANATORY STATEMENT

This determination revokes Determination No 133 of 1998 dated 24 June 1998 and notified in the Gazette No. S167 of 29 June 1998.

The Determination sets fees for the purpose of the Motor Traffic Act 1936 and has the effect of increasing fees for vehicle licences and permits. Set out below are the new fees (and previous fees) which apply to transactions relating to vehicle licences and permits.

The majority of fees have increased in line with the Consumer Price Index. The fees reflect the 1999-2000 budget strategy of the Government and will take effect from 1 July 1999.

## VEHICLE LICENCES AND PERMITS

Issue of a licence to move an unregistered vehicle
Licence to ply for hire of the carriage of goods valid for:

- one (1) year
- five (5) years

Permit to carry passengers on licensed goods motor vehicles or to carry workmen to and from their workplace, valid for:

- one (1) month
- one (1) year
- five (5) years

Grant or renewal of a licence to use a vehicle as a taxi
Transfer of a licence to use a vehicle as a taxi
Grant of a licence to use a vehicle as a motor omnibus

Renewal of a licence to use a vehicle as a private hire car
